Bar Options

Cash Bar ~ Guests purchase their own beverages while cruising.

Host Bar ~ Charterer will pay a minimum of \$25.00 per person bar deposit prior to the cruise. Upon reconciliation of the bar, payments are due upon docking and any refunds will be processed within 30 days.

Unlimited Pop ~ Charterer will pay a minimum of \$6.00 per person prior to the cruise. This includes assorted juices and soft drinks.

Drink Ticket Options

\$5.18* per ticket ~ May be redeemed at the bar for any beverage included in our Silver Package.

\$5.77* per ticket ~ May be redeemed at the bar for any beverage included in our Gold Package.

\$2.03* per ticket ~ May be redeemed at the bar for assorted juices and soft drinks, still and sparkling bottled water.

The Charterer must provide the ship's manager with any unused tickets upon disembarking for a refund 30 days after the cruise.
